- The number of faculty members in URDU department is too less to run a whole four years program.
- Learners take a lot of time in learning of the new courses because of low standards at HSSC levels.
- Books regarding the course content cannot be easily reachable.

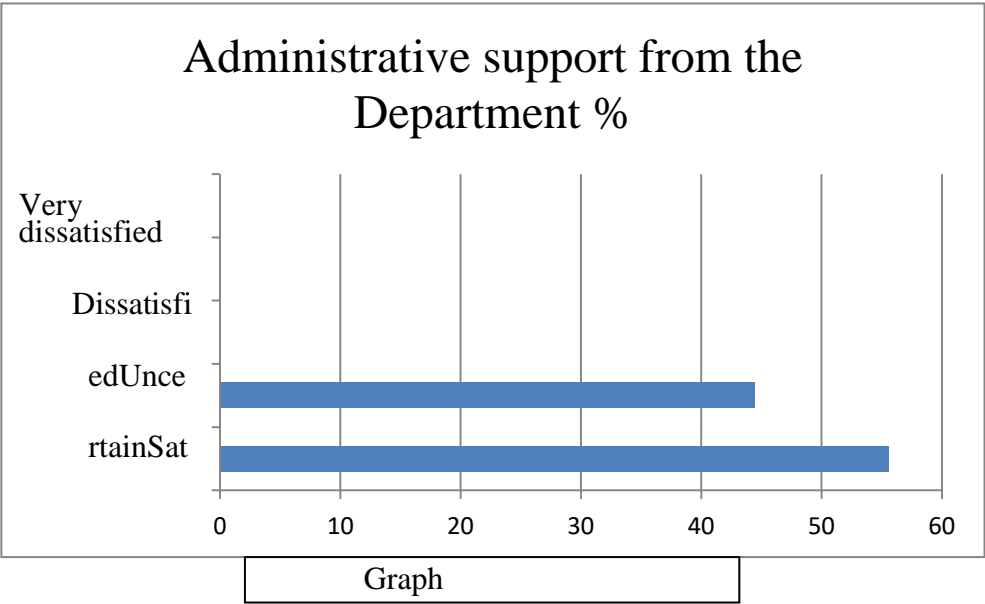

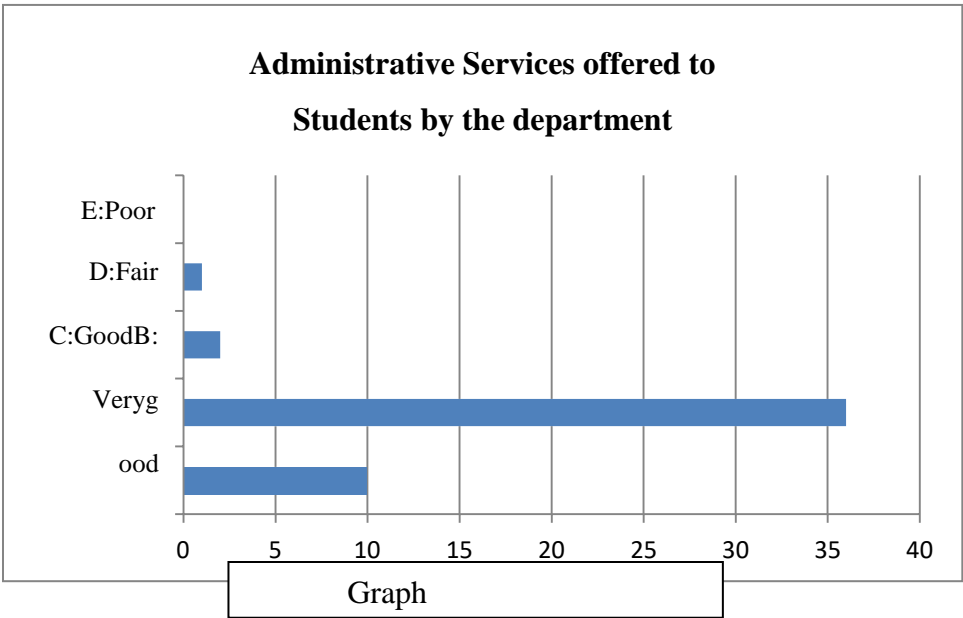

Students are always free to get their problem solved with professional guidance and counseling and they never feel alone.

The institute frequently arranges seminar, lectures and sermons to build their character. In this context a Character Building Society has also been established and different renowned scholars are invited to guide and support the students regarding various matters.

The students are given admission along with the prospectus which enables them to know about the program. Beside the college has exam coordinator. Who helps and guide them in their daily affairs in the college. Furthermore every teacher on her part takes an orientation class before going into the course. In that class the students are made acquainted with the BS system, grading and GPA etc. Describe how students are informed about Program requirements. Criterion 5: Process Control

Standard 5-1

The process by which students are admitted to the Program must be based on quantitative and qualitative criteria and clearly documented.

Admission Criteria for BS Program

1. Female candidates having domicile of District Karak are eligible for admission.
2. The candidates shall be eligible to apply for admission, which have at least 45% marks in the subject.
3. The candidates who have passed F.A/F.Sc or equivalent examination will be considered for admission in BS Program.
4. Maximum age limit is 20 years on the last date of receipt of applications for BS Program.
5. Age relaxation shall be granted in special cases by the Competent Authority up to 2 years.
6. All the admissions are made online. The detailed procedure is given on the HED /College website and community is made aware about admissions through social and print media.
7. The admission will be granted on open merit on the basis of following formula:
Total marks in F.A/ F.Sc + marks obtained in the major subject (where applicable). However, *Hafiz-e-Quran will be given additional marks.
8. For admission in the program, candidates are directed to submit an application in response to advertisement by HIMES of higher education Peshawar.
9. Admission for fall semester is done normally in September, special cases apart, while spring semester is commenced immediately after the fall semester.
10. Any candidate who has been punished by his previous institute for any indiscipline is not allowed for admission.
11. Every student has to submit an affidavit not to take part in political activities.
12. The admission will remain provisional unless all fees are paid and all testimonials and documents verified.

Note: Disable candidates will have to provide a disability certificate from the Social Security Department.

Documents to be submitted with the admission form:

The following documents must be submitted with the completed application form:

1. Three recent color passport sized photographs, dully attested.
2. Attested copies of Detailed Marks Certificate.
3. Attested copies of provisional/ original certificates.
4. Attested copy of character certificate.
5. Attested copy of CNIC of the applicant/father/ guardian.
6. Migration certificate
7. Original undertaking on judicial stamp paper of Rs. 20/- each, duly attested by politician
First class magistrate as PS specimen provided in the prospectus (admitted candidates only).

Disable applicants applying against the reserved seats must attach the relevant documents of eligibility with the form.

Eligibility Criteria for Admission:

The candidate must have a minimum of 12 years of education.

Intermediate, premedical, pre engineering, arts A levels or equivalent [at least 45% marks]

Migration and Transfer Policy:

A student from other college or university who wants to migrate to the college shall have following requirements.

- A genuine reason for the migration.
- Having a good character certificate from the previous institute.

Standard5-2

The process by which students are registered in the Program and monitoring of students' progress to ensure timely completion of the Program must be documented. This process must be periodically evaluated to ensure that it is meeting its objectives

Registration of students:

In the department student file of all admitted students is maintained and kept updated. The record include the Name, Father's Name, Date of Birth, Permanent address, CNIC No. of the candidate, DMC of SSC and intermediate Examination, details of any other examination and result card of every University Examination. The student name after the completion of the admission process, is forwarded to the registrar and the registration number is allotted.

The students shall be registered in the courses being offered by the university.

The form is available online and after filling and submitting online, a copy of it must be submitted for approval from the Head of the department.

The registration and semester fee is submitted manually in full, sometimes in parts.

Students not registered are not allowed to attend the classes. Students are offered 18 credit hours per semester not more. In otherwise case the students need to take permission from the controller of examination of the university. Students evaluation is done through the following criteria.

On the basis of present posts allotted by HEC, equal number of faculty is recruited in the colleges in BPS-17, BPS-18, and BPS-19 and so on.

On further need of the college especially in case of BS program, visiting faculty is also hired as per the rules designed by HEC. The vacancies are advertised in the newspapers and social media and thus communicated to the public. The shortlisted candidates are then called for the interview and demonstration. The selection committee recommends the suitable candidate.

Semester wise evaluation is done of both the regular and the hired staff.

Promotion is based on the seniority through PER submitted each year by the principal of the college.

Evaluation of the faculty is done each semester for further improvement.

The faculty delivers the lectures while students receive their lectures. The program is properly evaluated by the head of the department course advisors and QEC. The students are given the Performa regarding the course evaluation, how it was delivered. In other Performa the students give feedback regarding the teachers, effort put in delivering the course. These evaluation by the students enable the management to know about how the learning outcomes and up to which extent are met.

Besides, teachers are also given a feedback Performa regarding course evaluation. This aims at finding out the teacher's satisfaction level. They also point out the strengths and weaknesses of the course designed and the possible suggestion if there is any space. This exercise is done once a year.

To ensure effective student learning following procedures are followed:

The Head of the department keeps a record of the attendance of the students and if there is any student found not interested in the attendance, the HOD treats her strictly.

In case any teacher is absent on the day, the head of the department ensures makeup classes.

The head of the department keeps a check on the progress of the students by ensuring effective teaching to them.
